Re: Proposed initial public offering of equity shares of face value of ₹ 1 each (the "Equity Shares") of TBO Tek Limited (the "Company", and such initial public offering, the "Offer")

This is in relation to the red herring prospectus dated April 28, 2024 ("Red Herring Prospectus") filed with the Registrar of Companies, Delhi and Haryana at New Delhi (the "RoC"), the Securities and Exchange Board of India (the "SEBI"), National Stock Exchange of India Limited (the "NSE") and the BSE Limited (the "BSE", and together with the NSE, the "Stock Exchanges"), read with the addendum to the Red Herring Prospectus dated May 6, 2024 (together with the Red Herring Prospectus, the "RHP"), and read along with Price Band advertisement issued by the Company dated May 2, 2024, in connection with the Offer.
